

Due to the most recent litigation brought against the LHSAA, by nine principals in the parishes of Monroe City, Rapides, and Caddo, challenging the process in which the definition of select schools and its location within the handbook glossary was approved by LHSAA Executive Committee a special meeting of the LHSAA membership principals to approve the definition is now necessary. At the recent Fall LHSAA Executive Committee meeting, after a lengthy discussion with legal counsel present, a recommendation was made and out of concern that a ruling by the appellate court could interrupt or significantly alter the make-up of playoffs for our fall sports and that the ruling could come just before or even during the playoffs, it is in the best interests of our student-athletes and member schools that we vote on the previously adopted definition of select. A vote by the membership will alleviate the concerns raised by some schools that the previously adopted definition did not represent the will of the membership. At the direction of LHSAA Executive Committee President, Mrs. Shannon Foolkes, the decision was made to move forward with a special meeting. The LHSAA will now need 203 (six members dropped from the association) member school principals and/or an administrative designee previously registered by your school on the LHSAA member site to vote to accept or reject the definition.

Please know, designated LHSAA staff will be working expeditiously in locating a venue for this meeting. Once a venue is secured (much sooner than later) the date, time, and location will be disseminated to all 404-member school principals.

In closing, I thank the vast majority you for your continued communication and cooperation with this association, its executive committee, and the entire staff of the LHSAA.
